The Treasurer spoke with both our rate study consultant and our representative from DOR and they both concurred that the only way we can attempt to turn our finances around is to assess a tax to the District members. After explaining what assessing a tax meant - in addition to the already existing sewer betterment assessment and the monthly sewer usage bills, the Board was most definitely not in favor of this idea. Knowing this may be the case, a letter was drafted for their review with the objective to plead for help with our outstanding debt service. This letter will be sent to all local officials which include Governor Baker, Lt. Governor Polito, Congressman Jim McGovern, Senator Michael Moore, State Representative Kate Campanale and representatives from the DOR and USDA. The Board also requested that a similar letter be sent to the City of Worcester in hopes of a possible buyout or merger. Carla will re-draft a similar letter for the City and will have the Board sign at a later date.
