**I. CALL TO ORDER**

**V. OPERATIONS**

- A. Don Manseau relayed to the Board the content of the hearing he attended at Hebert Auditorium at Quinnsigamond Community College. Regarding the NPDES discharge permit issued by US EPA, who are trying to force the UBWPAD to reduce the phosphorus and nitrogen levels in the river. The revised permit will potentially require additional plant upgrades expected to cost 180 to 200 million dollars. This could cause a major impact in sewer rates.
- B. Don Manseau reviewed a letter addressed to him from the UBWPAD regarding the pH Limit listed in the CVSD Rules and Regulations. They are requiring that the CVSD revise the pH limit to 6.5 (currently listed at 5.5) and no higher than 10.0. Vic Taylor motioned to change this pH limit in the CVSD Rules and Regulations from 5.5 to 6.5 and no higher than 10.0. Mike DellaCava Seconded the motion. Voted unanimously.
